# FEDERAL AGENCIES FISHERIES SUMMIT OVERVIEW DOCUMENT

## **SUMMIT PURPOSE:**

The purpose of the Federal Agencies Fisheries Summit is to enable improved management and conservation of aquatic species and their habitats at the landscape scale by advancing relationships and collaboration across federal agencies.

## **SUMMIT OBJECTIVES:**

- Increase Understanding and Awareness of the roles, responsibilities, fisheries related missions, and authorities, of each federal agency.
- Build Community. Establish and improve federal agencies relationships and collaborative networks.
- **Shared Agencies Vision.** Develop a shared federal agencies voice and future vision for federal trust fisheries resources.
- Shared Collaboration Framework. Initiate a process to develop a collaborative federal agencies relationship framework and map alignment among federal agencies.

## **SUMMARY:**

The Federal Agencies Fisheries Summit (Summit) is an immersive, in-person, 3-day training event co-planned and co-hosted by several federal agencies with support from the American Fisheries Society. Summit target audience is federal agency staff that manage, research, or otherwise affect federal trust fisheries resources who are interested in crafting a new collaborative framework. The Summit will focus on management and conservation of freshwater, estuarine and near-shore resources and is intended to foster relationships, collaborations, communication, efficiencies and awareness among federal agencies rather than specific technical topics or applications. Summit participants will not be making any agency decisions or establishing any new guidance. A Summit proceedings summary document and materials archive will be made available after the event as a formal Summit record.

Summit participation is limited to a total of 125 participants. In-person interactions and discussions are critical for Summit success therefore, virtual/remote participation options will not be available. Each host agency will determine their agency participants and selection process. Participants will engage in hands-on mixed team activities that lead towards developing a shared federal agencies vision, shared call for action, and identify steps that can be used to develop a collaborative framework for increasing coordination, communication, and collaborations within and among federal agencies. In addition, a concurrent poster session throughout the facility will be available for those interested in bringing a poster highlighting current interagency fisheries projects and activities.

# **SUMMIT NEED/JUSTIFICATION:**

Fisheries and water resources challenges transcend agency and geographic boundaries, encompass multiple land ownerships, and solutions and expertise do not reside solely within any single agency. Research capabilities and goals vary

substantially across the federal agencies and each agency has developed areas of core strength as well as recognized areas of limitations. Challenges like rapidly declining aquatic resource conditions and flat or reduced agency funding warrant a new and innovative approach to inter-agency relationships. Federal agencies are well poised to identify and create a more modern, comprehensive, and shared, "all hands" vision for fisheries and aquatic resources management.

Recent energy and momentum around fish passage and aquatic biodiversity such as the H.R.3684 - Infrastructure Investment and Jobs Act and H.R.5376 - Inflation Reduction Act of 2022 provide a unique opportunity for advancing large-scale interagency relationships, shared visions, and collaborative plans for addressing the challenges and needs of our nation's fish and aquatic species. An impressive opportunity exists, but success depends upon a more structured and shared relationship vision and framework to plan, develop, share, learn, build upon, and demonstrate success from these activities within and across Departments and Bureaus.

The Federal Agencies Fisheries Summit is intended to be a foundational step to develop and outline a modern, shared federal agencies vision; and initiate the design and build up of this vision by better outlining how we interface and work with each other as federal agencies and within the larger aquatic conservation community.

## **SUMMIT TOPIC SESSIONS:**

Summit sessions will be conducted to increase collective understanding of agencies programs and approaches, create a shared vision, and map out options for a shared relationships framework to augment ways that the federal agencies interact and work together (or not) to address fisheries challenges and seize opportunities. Discussions and input received from all sessions will serve as the basis for a shared agencies Summit report and serve as material towards future products such as a shared agencies effort/impact map and possible interagency agreement.

In addition to plenary and close out sessions, the Summit will be comprised of an all-hands Tribal trust responsibilities session and three facilitated breakout sessions where individuals will work in small groups to share their perspectives on the following topics:

- Understanding the current situation regarding Federal interagency collaboration for fish and aquatic resources
- Exploring a shared vision for the future or purpose for a Federal interagency group
- Examining existing beliefs/behaviors/structures/etc. that currently preclude the group from achieving a shared vision/purpose
- Brainstorming short- and long-term strategies/actions that would assist the group in moving toward meeting their shared vision/purpose
- Identifying elements/evidence of success

## TRIBAL TRUST RESPONSIBILITIES SESSION

- This session will establish and create a forum for open discussions and explorations on federal agencies' roles and responsibilities related to Tribal trust fisheries resource rights, management, and research needs.
- The session is intended to be a key foundational step among federal agencies to help develop and outline a compelling shared federal agency vision specific to Tribal treaty rights and Tribal co-management of fisheries resources and initiate the design and build up of this vision by working with other federal agencies, and the larger aquatic conservation community.
- Lead agency for this all-hands session is BIA (with other agencies support) with representatives from Intertribal Fish and Wildlife Organizations and panel of federal agencies Native American Liaisons staff.

## VISIONING SESSIONS

- These sessions will provide the opportunity to share ideas about the future of federal fisheries within the United States, it will serve to increase our collective knowledge about what the federal fisheries trust entails. Lead agencies for each session are TBD. Participants will be assigned into session teams by the Summit planning team.
- Participants will discuss and explore new ideas that:
  - Provide the foundation for an initial shared future vision description of new ways of thinking about federal fisheries programs related to fish and aquatic species and what outcomes and new value that would create. Examples might include aligning federal fisheries management with research needs; improving our understanding of areas of critical need (by species, geography, etc); building a knowledge base for areas where fisheries resources should focus (such as aquatic connectivity, disease, habitat protection and restoration, water temperature, etc); and others.
  - Build a platform and community of practice where ideas/themes for our future vision for the state of federal fisheries programs can develop and reside, providing all federal agencies a fairly consistent approach to share with senior leadership, legislative interest groups, and other stakeholders.

## **COLLABORATION FRAMEWORK SESSIONS**

- These sessions will serve to generate a collection of ideas on collaboration framework elements to identify and transcend barriers to success in how federal agencies interact in addressing the pressing issues facing aquatic resources. Lead agencies for each session are TBD. Participants will be assigned to session teams by the Summit planning team.
- Participants will provide ideas, discussion and explore new ideas to:
  - Identify and create a list of resources, means, and mechanisms available for establishing a more collaborative framework for engagement. Examples include ideas on new workgroups, combined authorities, shared facilities, new funding streams, etc.

- Create an effort/impact map of agency roles, shared goals, rationale, and coordination mechanisms that can lead towards improved federal efforts for federal fisheries resources.
- Identify barriers to implementation of the mechanisms.
